- **For House Meetings:** The bill continues to grow its momentum in the House. As of 2/5 we have 207 bipartisan cosponsors, 150 Democrats and 57 Republicans.
  - The bipartisan Problem Solvers Caucus recently endorsed the bill.

## **DOD BCRP**

Discuss background of program—highlights document in your packet is a good resource.

- We thank Congress for supporting the DOD Breast Cancer Research Program through the passage of a FY26 Defense Appropriations bill. The final enacted version designated \$145M for the BCRP.
- We will be contacting you soon to sign a Dear Colleague letter supporting the program for FY2027. We urge you to sign that letter. It is critical to the continued robust funding of the program.

## **Healthcare Access**

- Breast cancer patients' lives depend on access to affordable and quality care. We urge the Senate to follow the House in passing a clean three-year extension of the ACA enhanced premium tax credits without delay.
- The Center for Medicare and Medicaid recently reported that 1.5 million fewer Americans have signed up for 2026 ACA plans so far, compared to last year. Further drop-off is expected. Families are already foregoing insurance coverage due to skyrocketing costs. Breast cancer patients and many more will suffer and die.
- Last week, NBCC shared with Congressional health staffers a Journal of the American Medical Association (JAMA) study showing that Medicaid expansion led to a 5% reduction in the risk of death for women with breast cancer. We cannot undo this progress.

## **Science Funding**

We urge Congress to strongly oppose any NIH and other critical biomedical research funding cuts. Any cuts will cost lives and erase decades of progress in improving patient health and saving lives of women and men impacted by breast cancer.
